2. New successful applicants must attend a special hunt orientation class to learn hunting boundaries, safety procedures, stand & step restrictions etc.
3. Submit a \$35.00 fee for time period desired. (Refunded if not drawn)
4. Report any kills or wounds to hunt chairman within 2 days.
5. Successful applicants will be notified via email about 14 to 21 days after drawing.
